

However, the site provides comprehensive resources useful to all families and professionals involved with children with disabilities.

## <u>California Collaborative for the Social and Emotional</u> <u>Foundations for Early Learning (CSEFEL)</u>



California is participating in the new early childhood professional development opportunity designed to support the social and emotional development of children birth through five. California is one of several states that has been

afforded the opportunity to receive training and technical assistance from The Center on the Social and Emotional Foundations for Early Learning (CSEFEL), funded by the Office of Head Start and the Child Care Bureau, Administration for Children and Families, U.S. Department of Health and Human Services. A collaborative of statewide organizations serving children birth to five are working together to implement CSEFEL conceptual framework of evidence-based practices for promoting young children's social and emotional competence and for preventing and addressing challenging behavior. The Map to Inclusive Child care Project with the California Child Development Division of the Department of Education are the leads of the collaboration. Fresno County recently conducted a self assessment of their progress on inclusion using SpecialQuest's Community Perceptions of Inclusive Practices tool. Representatives of all of the organizations serving very young children in Fresno County met to reflect on the current successes and challenges in 1) Including children birth to five with disabilities 2) Involving families of young children with disabilities 3) Providing integrated services to infants, toddlers and preschoolers with disabilities 4) Supporting implementation and sustainability. The tool is structured around "promising practices" related to each of these areas. The Fresno group was able to formulate new goals to address specific areas of need in their county as a result of their reflections using this tool. ### **NAEYC Cultural Competency Tool**



The Quality Benchmark for Cultural Competence Project (QBCCP) is an effort by the National Association for the Education of Young Children (NAEYC) to determine the essential elements of

cultural competence for early childhood programs and how to integrate these elements within quality rating and improvement systems standards. This work led to the creation of a new tool to serve as a guide to early childhood programs as they respond to the needs of diverse children and families. The tool further explains the project and the criteria that have been developed, as well as ideas for implementation and measurement.
