The California Map to Inclusive Child Care Project directs you to the latest publications, downloadable documents, and web resources supporting child care providers and al professionals who work with children with disabilities and their families. Map's website, funded through the Child Development Division of the California Department of Education as part of the WestEd Center for Child and Family Studies, is primarily geared toward providing resources to support child care providers in implementing inclusive practices for children with disabilities from birth to 21 years of age in their programs. However, the site provides comprehensive resources useful to all families and professionals involved with children with disabilities.

Resources to Support the Joint Position Statement on Early Childhood Inclusion

Quality Improvement Efforts in California Address Inclusion!



California Early Learning Quality Improvement System (CAEL QIS) Advisory Committee (established by SB 1629-Steinberg) is in the process of developing a plan to improve outcomes for children and promote school readiness by improving the quality of early learning and care programs for children from birth to five years old. The 2009 Interim Report

describes the CAEL QIS Advisory Committee's progress in assessing California's existing early learning and care infrastructure and in designing a new system. Included in the 2009 Interim Report is a description of the work initiated prior to CAEL QIS by the California Department of Education in partnership with First 5 California to develop Early Childhood Educator Competencies to describe core knowledge, skills, and dispositions for early childhood educators working with children birth to age five. These core competencies, to be completed by June 2010, will be aligned with the *Infant/Toddler* Learning and Development and the Preschool Learning *Foundations*, and will be included as a cornerstone of professional development in California. Draft competency areas include twelve different performance areas with one of them being Special Needs and Inclusion.

The Water Cooler is a collaborative effort by the Advancement Project, the California Community Foundation, First 5 California, and many other organizations representing interests in children from birth to age 18 to advance early care and learning for California's children birth to five. Members of this voluntary collaborative met in work groups several

times in 2009 to develop recommendations to improve the early care and education system in California. The Water Cooler Policy Report **November 2009** specifically addressed children with special needs and inclusion in recommendations from two work groups. The work groups recommended that special needs inclusion be an integral part of a Quality Rating Improvement System in California and that there be increased access to inclusive early care and education through increased training for the workforce.
